**RISK ACKNOWLEDGEMENT AND DISCLAIMER**

**ALL ADVENTURERS MUST SIGN THIS FORM**

- 1 - I am 16 years old and wish to take part in the Tree Top Adventure as provided by Raven Tree Top Adventure (RTTA).
- 2 - I am a guardian of an under 16 year old who wishes to take part in the Tree Top Adventure as provided by RTTA.
- 3 - If this form is being signed by a parent or guardian of an under 16 year old I declare that I am 18 years or older.
- 4 - I agree that I am responsible for any child within my care and will ensure that they have understood all safety briefings and the instructions set out by staff of RTTA.
- 5 - I declare that if I am not the parent or legal guardian then I have the authority and permission to sign this risk assessment and disclaimer.
- 6 - I understand that the Tree Top Adventure is a physically demanding aerial obstacle course and that there will be a risk of injury. For example, legs can be vulnerable to injury on zip wire landings and hands can be injured on ropes throughout the course.
- 7 - To reduce risk I agree to follow the instructions as given by the instructor in the briefing provided before and during my Tree Top Adventure and also any signage within the course area.
- 8 - In the event of an accident, or loss or damage to personal effects to myself or children within my care, I acknowledge that RTTA will not be liable for any direct or indirect loss, damage or injury arising from or in connection with the Tree Top Adventure (except any injury/death caused by RTTA negligence) and I waive all claims against RTTA in respect both to myself and/or children in my care.
- 9 - I certify that to the best of my knowledge neither I nor any children in my care have a medical condition which might make me/them more likely to sustain an injury or are pregnant.
- 10 - I acknowledge that I or any children in my care are not under any influence of alcohol or drugs.
- 11 - I agree to report any injuries to staff as soon as possible and also discuss with staff members & complete the accident register if required, during de-brief.
- 12 - I acknowledge that RTTA may occasionally take photographs of adventurers for promotional purposes - images can be used on our promotional material, website and social media sites. I give full permission for any images to be used for this purpose.
- 13 - I agree that I, and any children under my care will stay within the permitted areas and will not interfere with any equipment.
- 14 - I confirm that I, and any children under my care do not exceed 120Kg or 19St in weight.
- 15 - I agree that any personal property I take onto the course is at my own risk and RTTA will not be liable for any damage or loss.
